PLAINTIFF'S RESPONSE TO DEFENDANT'S MOTION TO DISMISS, "SWORN AFFIDAVIT OF NEGATIVE AVERMENT," AND "NOTICE OF FAULT WITH OPPORTUNITY TO CURE"

COMES NOW National Collegiate Student Loan Trust 2005-3, Plaintiff in the abovestyled action, and files this its response to Defendant's Motion to Dismiss, "Sworn Affidavit of Negative Averment," and "Notice of Fault with Opportunity to Cure," and shows the Court as follows:

Defendant has served Plaintiff's Counsel with a Motion to Dismiss, a "Sworn Affidavit of Negative Averment," and a "Notice of Fault with Opportunity to Cure."
