Payments must be in a form that keeps your donation private and confidential, *no bank checks or “to” and “from” will be accepted.*

VI. SPCDONE4U CLIENTS:

A) Certificate of Live Birth

Scan your BC (front & back) and save as a PDF labeled “Your Name BC” (Refer to Guidelines on Sending Documents in contract- no cell phone scans/pictures). Email to filings@understandcontractlawandyouwin.com along with your SPC Form (below)

B) Secured Party Creditor Form

Download SPC Form on <http://understandcontractlawandyouwin.com/spc-ucc-filings-aka-redemption-process/> and “enable macros” when opening and saving excel file.

Please thoroughly follow the specific instructions under each box and review after you are done before sending. This will allow us to get your process started and not waste additional time reaching out to you on something that was missed or not filled out correctly. We know these are important considerations for creating your Trust so please take your time.

- Email Certificate of Live Birth & SPC Form to filings@understandcontractlawandyouwin.com (Please save and label appropriately for faster processing)

Once your signup is complete and your SPC intake has been reviewed (typically 3 business days), you will receive an email confirming the Processing Department will now start your paperwork. Please wait 14 business days for your paperwork to be populated and checked for accuracy by three different people. This waiting period has officially begun once you have completely and accurately filled out your SPC Form and sent us a clear (not cut off, crooked, etc) BC. Doing this right the first time will not only be appreciated by us, but will get your paperwork started much sooner and will start a good habit of following instructions, reviewing, and sending paperwork for each step of your SPC filing. Thank you for your commitment to excellence, empowerment, and freedom!

REMINDERS ON SIGNING / SENDING US DOCUMENTS

1. Have access to a Notary. You can go to your local bank, they do it for free. You do not need to use the same one everytime. If you also know a notary who knows your identity and doesn't need to see your Drivers License ID, that's cool, but not absolutely necessary or as important as getting the docs signed and over to us quicker.
2. It is necessary that you have access to a computer, printer, scanner - and highly recommended to own them at home or somewhere readily accessible. You can use Staples "Copy and Print Center", or at Office Max as a backup please keep in mind: you are responsible for saving and labeling files appropriately. Save and label yourself *before* emailing us (see #3 below). We do not accept documents from anyone but you directly. As you will be scanning every document you sign back to us, listening to our corrections, and then re-signing again several times (perhaps 5-6 in total). Therefore if you need to buy one, look for sales in the flyers you get in the mail or elsewhere, Staples, Office Max, Amazon, sell all-in-one printer/scanner as affordable as \$50-\$120 on up.
3. PLEASE, when emailing us your documents, please save the files AS something relevant such as this formats:
"YOUR NAME STEP 1 SIGNATURES TRUST DOCS",
"YOUR NAME PUERTO RICO DOCS SIGNED"
"YOUR NAME NOTIFICATIONS OF RECORD SIGNED"

and if your docs are in several files, please do:
"YOUR NAME STEP 1 SIGNATURES TRUST DOCS 1 of 3", "YOUR NAME STEP 1 SIGNATURES TRUST DOCS 2 of 3",
etc Nice and clean and easy for us to work with!
4. Please do NOT send documents via taking photos of your CELL PHONE! They have shadows of your hand bouncing onto the document, not very professional. Spend the \$50 on a scanner please.
5. Please do NOT send documents 1 file at a time. Most scanners, if you feed it through or scan 1 page after another, will save the file to ONE pdf for you. I don't want 54 individual files just for your *Draft Step 1*!!! That's insane to work with sort through or find later.
6. Some people email us their documents as they are saved by the scanner as "SCAN0086", etc. Please keep in mind that when this saves in our download folder, there will be THOUSANDS of documents in the folder that look like this. Please help us help you and save your files with names we can find easily so your process is not delayed. Spend extra time doing it the first time, we greatly appreciate it!
7. Also please save your files as a PDF format, NOT an image (jpg/bmp/gif) file! Every single modern model computer scanner of today either by default, or with a slight selection on the outside of the scanner, you can select under "save as" "PDF file" "to computer" or "to usb drive".
8. Make sure to scan the documents to us RIGHT SIDE UP, not upside down. So, please LOOK at your files when they are scanned in to make sure they are right side up and look alright; before emailing them to me. Please help me help you!
9. If you are a client doing the SPC Filings, please send your original documents to get

started to: filings@understandcontractlawandyouwin.com NOT to the contact@under... address; this way you get priority attention like a paying client should! The Contact@ email is for general inquiries please don't send emails there related to your filings or any follow up process you need afterwards. You deserve priority access and so this is the email for you!
